### 2. Minutes

#### A. Minutes of June 9, 2010

The minutes from the June 9, 2010 meeting were presented for approval.

**Mr. Myles made a motion to approve the minutes. Mr. Onley seconded the motion. The minutes were approved unanimously.**

##### A. Brunori Withdrawal Request

Mr. McGowan reported that the Planning Commission recommended disapproval of the rezoning, and the application had been withdrawn. Mr. McGowan recommended that the Committee consider waiting to remove Mr. Brunori's parcels from the district until the 4 year review period.

**Mr. Taylor made a motion that the Committee wait until the 4 year review period in the Spring of 2011 to remove Tax Parcels 42A1-3-1, 42A1-3-2, 42A1-3-**

**New Business**

**A. Review of Modestown AFD**

Mr. Testerman presented the Modestown A&F District information, including the map of the parcels to be removed from the Modestown A&F District. Mr. Onley, who owns land in the district said the recommendations appeared be correct.

**Mr. Mills made a motion to recommend continuing the Modestown Agricultural and Forestal District with modifications of properties within the districts and modifications of the district conditions to include the provisions of the Model Agricultural and Forestal District Ordinance, adopted on May 16, 2007. Seconded by Mr. Myles. Mr. Onley abstained from the vote because he owns land within the district. Among the remaining committee members, the motion passed unanimously.**

**B. Discussion of Regular Meeting Date**

The Committee agreed to wait on setting a date until regular meetings become a necessity, most likely the Spring of 2010.

No other business was discussed.
